### **Ques 3: Who is eligible for obtaining consent?**

**Ans:** As per **Section 21(A)** of Air (Prevention & Control of Pollution Act 1981) No person shall, without the previous consent of the State Board, establish or operate any industrial plant in an **air** pollution control area and as per Section **25(A)** of the **Water** (Prevention & Control of Pollution) **Act**, **1974** Prior Consent of the State Board under section **25** is necessary to set up any industry, plant or process which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land.

White categories of units do not require consent. However such white category units are required to submit undertaking online on DPCC portal.

# Ques 4: Who is eligible for obtaining consent in notified Redevelopment Area?

#### Ques 5: Where do I go and during which hours?

**Ans:** No need to visit office of DPCC for filling Consent application. Consent application can only be submitted online 24\*7 on user friendly software on DPCC website.

#### Ques 6: Are applications forms priced?

**Ans:** Application for consent is to be submitted online only. DPCC does not accept consent applications offline. Consent fee also to be submitted in digital mode. Provision of fee calculation is inbuilt in web based software while submitting the application online. Therefore issue of price of application form does not arise.

#### Ques 8: Which papers/documents/fee, do I take with me?

**Ans:** All the requisite documents can be seen at <a href="https://dpccocmms.nic.in/userMaster/dowloadForm.gsp">https://dpccocmms.nic.in/userMaster/dowloadForm.gsp</a> these documents are to be scanned and uploaded while filling the online consent application. The consent fee is required to be submitted through digital mode only as per provisioning of software.

#### Ques 9: What will be the Criteria used while deciding my case?

**Ans:** The General criteria used are:

- (a).Location of the unit.
- (b). Permissibility of the activity as per MPD-2021.
- (c). Completeness of information given in the form.
- (d).Installation of Effluent Treatment Plants (ETPs)/Emission Control System (ECS), if required.
- (e). Status of D.G. Sets and acoustic enclosures provided to DG set.
- (f). Findings during inspections conducted (if any).

#### Ques 10: When will I get a response?

**Ans:** Consent application under II(a) are decided by the Committee headed by Chairman, DPCC. Consent applications under II(b) category are decided by the Committee headed by Member Secretary, DPCC and consent applications under category I are decided by Sr. Env. Engineer of concerned cell of CMC.

# Ques 11: Are the consent to Establish/Operate granted in non-conforming areas. If not why?

Ans: Consent is not granted in non-conforming areas in violation of MPD 2021. Hon'ble Supreme Court has passed an order on 07.05.2004 in I.A. No. 22 in WP(c) No. 4677 of 1985 titled as M.C. Mehta Vs. Union of India & Others for closure of the units from the residential/non-confirming areas in NCT of Delhi. As per the said order, all industrial units that have come up in residential/non-confirming areas in Delhi on or after 1st August, 1990 shall close down for operating in violation of MPD 2021. Permissible units as per MPD 2021 may apply online for consent to Establish /Consent to Operate or submit undertaking for White category as the case may be.

# Ques 12: We are not a water polluting/air polluting industrial unit. Do we need to apply for consent with DPCC?

**Ans:** As per **Section 21(A)** of Air (Prevention & Control of Pollution Act 1981) No person shall, without the previous consent of the State Board, establish or operate any industrial plant in an **air** pollution control area and as per Section **25(A)** of the **Water** (Prevention & Control of Pollution) **Act**, **1974** states that Prior Consent of the State Board under section **25** is necessary to set up any industry, plant or process which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land or bring into use any new.

- (a) establish or take any steps to establish any industry, operation or process, or any treatment and disposal system or any extension or addition thereto, which is likely to discharge sewage or trade effluent into a stream or well or sewer or on land (such discharge being hereafter in this section referred to as discharge of sewage); or
- (b) bring into use any new or altered outlet for the discharge of sewage; or
- (c) begin to make any new discharge of sewage

### Ques 13: I am involved in trading activity. Do I need to apply for consent?

**Ans:** As per Water/Air act, all trading activity emitting any type of air pollutant or discharging any effluents in the drain through waste water need to apply for Consent.

## Ques 15: I have an office and have installed a D.G. Set. Do I need to take consent from DPCC?

**Ans:** The consent is not to be obtained in the case of standalone DG set(s) or the DG set(s) installed within the residential buildings, shops, offices etc. However, these DG set(s) are required to comply with the standards/ norms prescribed under Environment (Protection) Rules, 1986.

## Ques 16: I have a warehouse. Do I need to obtain consent from DPCC?

**Ans:** Warehouses have been categorized in White Category as per categorization of DPCC and are required to submit an undertaking for obtaining an acknowledgement. The acknowledgement serves the purpose of consent for warehouse.
