Eligibility Criteria

- ✦ The applicant shall be entitled for No Objection Certificate if he/she is-
1. Individual who is the citizen of India and having permanent residence in Delhi
 2. The person should be an ordinary resident at the address currently residing
 3. Women not originally belonging to Delhi, but married to men who is permanent residents of the Delhi
 4. Having Property in jurisdiction of NCT

Facilitation Charges

- ✦ A facilitation charge of Rs. 100/- (*per service request*) is to be paid for issuance of No Objection Certificate. Copy of issued No Objection Certificate (*With in a Validity Period*) can be printed any number of time by citizen free of cost from website www.DelhiDistrict.gov.in or by any e-District kiosk throughout Delhi by paying printing charge of Rs. 10/- *per copy*. If No Objection certificate Service is rejected then **no printing charge** will be charged for the copy of Rejection letter.

Important Note

- ✦ Self-attested copy of the original documents to be produced while applying at e-District Kiosk and if applying online then document are to be uploaded in e-District application software.
- ✦ Affidavit has to be notarized and should be on Rs. 10/- Non-judicial e-stamp paper
- ✦ The applicant himself/herself should be present at the kiosk for photograph or submit his/her photograph. In case of online application, applicant must upload photograph (*As per specifications*)
