## FAQ in r/o Registration of Establishment under Bed and Breakfast Scheme

<u>Introduction</u>: Vide Notification No.F.6(11)/TSM/2007/Part file/941 dated 06.09.2007, in exercise of the powers conferred by Section 33 of the National Capital Territory of Delhi (Incredible India) Bed and Breakfast Establishments (Registration and Regulation) Act, 2007 (Delhi Act 11 of 2007), the Government hereby makes the following rules, namely:-

8	What documents are required for registration of premises under BNB?	Following documents (duly self attested) required for registration of premises under BNB:  1. Ownership proof of applicant (legal documents) i.e. Conveyance Deed, Sale Deed, GPA (Registered), Lease Deed or SPA/Authorization duly registered in case of applicant is not actual owner.  2. Police Verification Report (Form-B) of the applicant  3. ID proof of residence of applicant such as Driving License, Passport, Ration Card, Aadhaar Card, Voter ID.  4. Undertaking/Self Declaration by applicant on plain paper  5. Layout Plan of all floors (separately on A4 size sheet)  6. Family background note of the applicant.
