# GRANT OF LICENCE UNDER CONTRACT LABOUR (REGULATION & ABOLITION) ACT 1970

#### Eligibility Criteria

- ✓ The applicant must be the citizen of India.
- ✓ The applicant must be a resident of the territorial jurisdiction of NCT of Delhi.

## Mandatory Documents

- ✓ Application in (Form-IV) under the Contract Labour Act Rule 21(1)
- ✓ Form-V issued by Principal Employer [Rule 21(2)]
- ✓ Affidavit for legal compliance including condition of licence i.e. Rule-25 of the rules.
- ✓ Self attested copy of registration of workmen employed by the contractor ,Rule 75, Form XIII
- ✓ Self-declaration as per the prescribed format.

- should be of full head from top of hair to shoulder
- shouldn't be shadows on the face or background
- should not include sunglasses or hats
