Eligibility Criteria

The applicant is entitled for Solvency Certificate if he/she is-

- ✓ An Individual who is a citizen of India.
- ✓ AnIndividual who is a permanent resident of Delhi
- ✓ Having property within the territorial jurisdiction of NCT of Delhi.

 - should have a natural expression (closed mouth)
- should be of full head from top of hair to shoulder
- shouldn't be shadows on the face or background
- should not include sunglasses or hats

Important Note

- Applicant'sself-attested copy of the original document to be produced while applying at Citizen Service Centre (CSC) and if applying online then document are to be uploaded in e-District application software. Physical verification of some documents may be necessary at the counter even in case of online applications.
- Scanned copy of original self- declaration has to be uploaded while applying online and original declaration form has to be submitted to the concerned SDM/Tehsildar/CSC by hand or speedpost/registered post along with Application /Acknowledgement number.
